<u>NW Children & Young People (CYP)</u> <u>Neuro-Oncology Study Day</u>

Background

The Neuro-Oncology Nurse Specialists across the 2 Principal Treatment Centres (Alder Hey Children's Hospital & Royal Manchester Children's Hospital) within the North West of England identified an educational opportunity within the Paediatric Neuro-Oncology specialty.

<u>Purpose</u>

Enhance Multidisciplinary Knowledge; improve the understanding of the developments in the diagnosis, treatment, and long-term care of CYP with brain and spinal tumours, across all disciplines involved in their care.

• Highlight the Lived Experience; incorporate the experience of CYP and families to shape services and improve holistic care throughout the neuro-oncology pathway.

• Encourage Regional Interconnection; strengthen professional relationships across the region to ensure equitable access to high-quality care.

• Support Professional Development; offer continuing professional development (CPD) opportunity within the specialty that equip professionals with further practical knowledge, tools, and strategies to support children and young people living with neuro-oncological conditions.

97 delegates attended and 16 speakers & lived experience reps.

The Brain Tumour Charity attended as an exhibitor to showcase their services available and to link in with professionals across the region.

The Under 16 Cancer Patient Experience Survey asks questions about NHS cancer or tumour care. The survey is sent to children under the age of 16 and their parents or carers who have recently had care at Principal Treatment Centres (PTCs) in England. Some children who are 16 years old may also be sent a survey if they received care within the past year as a 15 year old. Picker have been asked to run the survey by <u>NHS England</u>.
